	I hereby give permission for my child to have a general sight/hearing checks when held at the school.	
]	Head Lice	
	When cases of head lice are experienced, children who are found to be infected will be required to be treated with an appropriate treatment. Consequently, infected children may not return to school until such treatment has been carried out. I understand and accept that if my child is found to be infected	
	with head lice, they will be withdrawn from close contact with other children until collected on treatment by parents/caregivers. I further understand that I will need to collect my child promptly if head lice are evident as a result of a check.	
	I consent to my child having his/her hair checked for head lice, when required.	
	Photographs/Videos I give permission for the school to print or display a photo of my child in either the school newsletter, school work display (in the school and within the community), magazine or general information flyer, school video or on the school website.	
	Year 8 and 9 - I consent to the school using my child's name, D.O.B., and ID number for the purpose of providing them a Student ID card.	

My child is able to have sunscreen applied, when necessary. I have supplied a sun protection cream for my child as they have an allergy to sunscreen ICT Device and App Usage I acknowledge that mobile phones, personal listening devices, or any device intended for individual use without being audible to others are not allowed at school, and such devices must not be used at school for taking photographs under any circumstances. I give permission for my child to use educational apps installed on school devices, and apps will be installed by the school as required. I acknowledge that students are required to use ICT facilities only for educational purposes, report any IT issues to school staff and not attempt to repair or alter equipment. If a student damages any ICT equipment the extent of damage is communicated with the family. It is expected that the student and/or family assist in covering the costs of repair. Safe Internet Usage I understand that Internet access is provided for educational purposes, and students are expected to exercise caution when accessing online services. They must not access content that is illegal, dangerous, violent, offensive, or related to gambling. All internet usage is monitored, and browsing activities are reviewed. If students accidentally encounter inappropriate material, they should immediately clear it from their screen and inform their teacher discreetly. For safety reasons, students must not share personal information, such as home addresses or phone numbers. Additionally, students must adhere to copyright regulations and seek guidance if unsure. Failure to properly credit online sources may result in their work being considered plagiarism. Library I agree to be responsible for all library materials borrowed by my child, and will be responsible for lost or damaged materials. I agree for my school account to be charged at the end of each term to replace the item/s. Yard Supervision I understand that the school yard is supervised from 8:30am until school begins and until 3:45pm (or until last child has left, if earlier) Monday to Friday on school days. Students should only be at school during supervised times or when required for school activities. Clean Up Crew I give permission for my child to participate in the Crossways Clean Up Crew. To ensure their safety, students will be provided with appropriate safety equipment, including gloves, tongs, and bags. At the end of the excursion, hand sanitizer will be provided before students board the bus.

The schedule will vary, so students do not miss the same lesson each week.

Viewing Component
I understand that in many of the teaching programs my child experiences; there will be a required viewing component. My child may view a range of texts such as: documentaries, films extracts that complement the classroom learning program.
